### **Junior Board Qualifications**

Young professionals and law students<sup>1</sup> under the age of 40 may submit an application for Volunteer Lawyers Birmingham (VLB) Junior Board membership.

### **Junior Board Membership Agreement**

- 3-year term commitment;
- Attend at least two-thirds of all Junior Board meetings annually;
- Volunteer at one or more VLB help desks or clinics annually;
- Serve at the Junior Board's annual fundraising event;
- Pay \$150 annual dues<sup>2</sup>;
- Satisfy the annual "Give/Get Policy" by making a financial impact for the benefit of VLB in the amount of \$500<sup>3</sup>; and
- Assist in recruiting quality Junior Board members from diverse backgrounds, both culturally and professionally.

### **Junior Board Officers**

The offices of President, Vice President, and Secretary/Treasurer will be elected annually, with additional officer positions and committee chairs added at the discretion of the Executive Committee.

### **Junior Board Meetings**

Junior Board meetings will be held regularly (6-8 meetings per year). Additional meetings for special committees will be scheduled as needed.
